Subcommittee Charges and Status: Review of DoD Centers

- **September 17, 2002 request by Dr. Winkenwerder, the Assistant Secretary of Defense, Health Affairs (ASD(HA)), to:**
 - Meet with the DoD Centers for Deployment Health Research and Clinical Center Directors to receive mission briefs
 - Develop, in coordination with the Directors, an appropriate strategy to accomplish an ongoing program review and appointment of an AFEB Select Subcommittee (Military Occupational/Environmental Health and Medical Surveillance Subcommittee) to serve as a public health advisory board for the DoD Research and Clinical Centers for Deployment Health



Subcommittee Charges and Status: Review of DoD Centers

- **Deployment Health Research Center**
 - Completed review of DHRC following site visit on May 11-12, 2010
 - Subcommittee recommendations presented at August 18-19, 2010 DHB meeting and approved by the DHB Core Board
 - “Review of the Department of Defense Center for Deployment Health Research Center” finalized on August 18, 2010

- **Review of Deployment Health Clinical Center (DHCC) at Walter Reed and the Armed Forces Health Surveillance Center (AFHSC) at Aberdeen Proving Ground: awaiting scheduling for preliminary visits**

- **On 25 June 2010, the Office of the Inspector General (IG) requested input and comments on questions posed by the IG regarding the Qarmat Ali water treatment plant in Iraq**
