c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The purpose of Enterprise Blood Management System (EBMS)-Transfusion, formerly known as Blood Management Blood Bank Transfusion Service (BMBB/TS), is managing the blood transfusion aspect of the Armed Services Blood Program (ASBP), including blood records, blood orders, and transfusion patient information in the Continental United States and Outside Continental United States. EBMS-Transfusion manages the Military Treatment Facility (MTF) inpatient and outpatient blood test results for transfusion compatibility and provides the following high-level functionality: automate operations while giving MTF staff the control needed to manage specimens, orders, blood products, derivatives, and routine and electronic cross-matching; manage supply to meet demand with an easy-to-use inventory overview screen with real-time updates; track patient history and raise the bar on patient safety with over 60 built-in checks and real-time patient monitoring to pro-actively alert staff of potential errors.

EBMS-Transfusion is a Commercial off the Shelf product (COTS) manufactured by WellSky® and is FDA Class II regulated. EBMS-Transfusion replaced the Defense Blood Standard System.

The types of personal information about individuals that will be transcribed/maintained in the EBMS-Transfusion system include contact information, birth date, names, child information, demographic information, other ID, Protected Health Information (PHI), and Social Security Number (SSN). The groups represented in the system for which PII is collected are Service members, Department of Defense (DoD) beneficiaries, Department of Veteran Affairs patients, civilian patients, and foreign nationals.

EBMS-Transfusion is accessible to authorized users, including those who may be considered the general public (i.e., government civilians, military, and contractors), from 20 DHA Blood Donor Centers (BDCs). Access to a system hosted web application is restricted to the authorized users previously mentioned, and cannot be accessed by the public at large.

EBMS-Transfusion is owned and managed by the Electronic Heath Record (EHR) Core Program Management Office (PMO) under the executive management of Defense Health Agency (DHA), DAD IO/J-6, Solution Delivery Division (SDD).

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

PII is being collected for verification of the transfusion patient in determining patient suitability for blood transfusions and for the purposes of testing and look-back implications. The intended use of the PII is to support the ASBP mission of providing quality blood products to customers and to ensure a safe and secure blood supply for transfusion patients.
