c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The Informatica Common Services (ICS) system is a new application and common service offered by the Solution Delivery Division (SDD) built upon the Informatica PowerCenter platform that provides extraction, transformation, and loading (ETL) workflow features for the Defense Health Agency (DHA) applications. The system provides interfaces among DHA/SDD systems and also allows for systems to securely receive data from external partners. Personally Identifiable Information (PII)/Protected Health Information (PHI) is collected by connected tenant applications/systems and stored in tenant controlled databases and repositories; only being processed and transmitted in the form of metadata (data about data) by the Informatica PowerCenter application and associated databases while within the ICS authorization boundary.

ICS does not collect or use PII directly. ICS only ingests data from connected tenant applications/systems. Tenant applications/systems users ingests PII/PHI from sources that include: Members of the Armed Forces; Department of Defense (DoD)-affiliated personnel (includes DoD civilian employees, DoD contractors, and DoD foreign national employees), spouses and dependents of members of the Armed Forces and DoD-affiliated personnel.

Types of personal information collected by tenant systems and subsequently processed/transmitted by ICS includes but is not limited to: personal descriptors, ID numbers, ethnicity, employment, and education information.

ICS is not accessible via a public facing website or interface. The system is not intended for public access, and access is granted by an ICS administrator with approval of a formal authorization request via DD 2875 by the system owner.

ICS is owned and operated by DHA SDD.

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

The PII is collected for data matching and mission-related use purposes. The intended use of the PII is to transmit and process in the form of meta data (data about data) during the extraction, transformation and loading processes performed to prepare their data to be stored in data warehouses that reside within the authorization boundary of these source tenant application systems.
