MEMORANDUM FOR SENIOR PENTAGON LEADERSHIP DEFENSE AGENCY AND DOD FIELD ACTIVITY DIRECTORS

SUBJECT: Continuing Implementation for Reform of the Military Health System

This memorandum directs the continued implementation of the Military Health System (MHS) organizational reform required by law. Reference to military medical treatment facilities (MTF) in this memorandum includes dental treatment facilities. This reform is guided by the Department's focus on the quadruple aim: improved readiness, better health, better care, and lower cost. The Department will continue to advance these objectives through specific organizational reforms required by law and consistent with direction from the Secretary of Defense and the National Defense Strategy.

Effective immediately, the Department will take another significant step toward making the Defense Health Agency (DHA) responsible for the management and administration of all MTFs. To accomplish these important Department objectives, I direct the following:

- Authority, direction, and control for all MTFs not currently under DHA authority, direction, and control will transfer from the Military Departments (MILDEP) to the DHA, to include those overseas MTFs listed in Attachments 1 and 2.
- During Fiscal Year 2022, these organizational reforms will continue to be executed through Direct Support (DS) agreements entered between DHA and each MILDEP. as necessary across the Department. These agreements ensure the operation of the MHS continues in an efficient and effective manner during the transition of capability and resources from the MILDEPs to DHA. DHA established and continues to refine a conditions-based approach that requires it to meet clear, objective criteria that demonstrate the DHA's capability and capacity to manage MTFs. DS will end in a phased approach as these conditions are met.
- No later than July 1, 2022, the Under Secretary of Defense for Personnel and Readiness (USD(P&R)) will submit an update to me on the progress of the MHS transition and an updated implementation plan incorporating any new or revised legal requirements. This updated plan will include potential shortfalls, continuing challenges in implementation of this transition, as well as conditions-based milestones and anticipated timeline to transition all functions and capability for the administration and management of MTFs from the MILDEPs to DHA and shall ensure statutory compliance.

The MHS governance process will oversee DHA's progress toward meeting the transition conditions under the DS framework and will make recommendations, as necessary, to ensure the Department meets transition plan goals and milestones.
