c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The Web Medical Care Support Equipment (MEDCASE) Requirements and Execution (WebMRE) version 1.x system is a database and web application that is developed for the Defense Health Agency's (DHA's) Integrated Clinical Systems Program Management Office (ICS PMO). The WebMRE system is a Platform as a Service (PaaS) hosted on the DHA's Data Center Operations Branch (DCOPS) virtual environment. The WebMRE system is designed to provide detailed information, requirements data, and execution status to assist in the management and control of the MEDCASE/Super Capital Expense Equipment Program (SuperCEEP). WebMRE system will provide detailed information of Medical Device Equipment located in the Army's Medical Treatment Facilities (MTF's) to assist with the requirements generation, life-cycle management and Planning, Programming, Budgeting and Execution (PPBE) process for Army Medical Equipment and general users. The system was a legacy application that was developed in Oracle 11g and was upgraded to Oracle 12c. The system was migrated from legacy application of Cold Fusion to ASP.NET MVC 5 Framework. The WebMRE System application is a database to manage the data captured via user interface. Front end of the application is developed using ASP.NET. The backend will use ORACLE 12c.

The entire functionality of the system is analyzed and divided into modules/tabs and each of them is integrated with a unified interface for user navigation. WebMRE Web Server will use Windows 2016 or Higher with 6 Gigabytes (GB) memory, IIS 10. The Database Server has 12 GB ram and will use ORACLE 12c for the Database. Web development tool is Visual Studio 19. Entity Framework 5, object-relational mapper (O/RM), Bootstrap 3 and Oracle Managed Oracle Data Provider for .NET (ODP.Net).

The system will be hosted on Non-Classified Internet Protocol (IP) Router Network (NIPRNET). The system can support Assured Compliance Assessment Solution (ACAS) scanning, and Host Based Security System (HBSS) is installed. Department of Defense (DOD) site admin have access to the system. Automatic patching will be implemented through System Center Configuration Manager (SCCM). The system does not contain any Personal Identifable Information (PII) or Protected Health Information (PHI). The baseline site is Ft Sam Houston, San Antonio, TX. Web MEDCASE Requirements and Execution 1.x AA 2990 is owned and operated by Defense Health Agency's Integrated Clinical Systems Program Management Office.
