



Network Assessment: Lakehurst (1 of 2)

Scenario: Closure of outpatient / ambulatory clinic



- 100% of MTF Prime, Reliant and Plus beneficiaries are living within the 30-minute drive-time boundary for Primary Care, concentrated around the MTF location
- 99% of MTF Prime, Reliant, and Medicare Eligible beneficiaries are living within the 60-minute drive-time boundary for Specialty Care, concentrated around the MTF location

Note: To estimate the geographic market within a 30-minute, and 60-minute, drive time of the MTF, we assumed an average driving speed of 30 MPH, and thus a 15 mile radius for the 30-minute standard, and a 40 mile radius for the 60-minute standard, around the Zip code of the MTF was determined as the geographic market

Network Assessment: Lakehurst (2 of 2)

The potential impact of new MHS Beneficiaries on the total population is well below the 10% threshold for both population groups and thus will not materially impact supply and demand of services in the Lakehurst market




Commercial Physical Medicine / Rehab providers within the 60-minute drive-time standard are capable of accepting the specific demand from the **3,110** impacted beneficiaries.



Current Supply

- There is a more-than-adequate supply of Physical Medicine / Rehab providers to cover the increased demand for the impacted TRICARE beneficiaries



Forecasted Demand

- Population growth over the last five years (2014 to 2018) has averaged 1-2%, and is projected to increase slightly over the next five years at 2-4%
- This moderate level of growth will result in a large surplus of Physical Medicine / Rehab providers





Resulting Shortage/Surplus



- The NBHC Lakehurst is located 40 minutes from both NBHC Earle and 87th MDG and 4 hours from Annapolis. The healthcare team consists of 30 Active Duty, GS, and Contract staff.
- Services include primary care, dental, Occ Health/Ind Hygiene, Prev Med, and ancillary services of lab, pharmacy, and plain film radiology.
- Primary care - 1 PCM cares for 759 enrolled beneficiaries (51% AD).
- 718 annual "must see" non-enrolled patient encounters (Center for Naval Aviation Technical Training Students, Coast Guard, Recruiters, etc.)
- Approximately 800* civilians onboard NSA Lakehurst currently tracked by OH.
- Surgeon General's approval for the NBHC Lakehurst transition was signed 28 Aug 18 (backup slide 9) with the intention of retaining OH/IH/preventive medicine onboard NAS Lakehurst and realigning to utilize alternative military facilities and MCSC for the remainder of care.
- The current NBHC Lakehurst UIC will remain active following the conclusion of the transition, assigned to retained services.










