PROGRAM OVERVIEW

The Program Executive Office, Defense Healthcare Management Systems (PEO DHMS) is an acquisition organization that oversees three program offices. These offices acquire, deliver and support information technology and services that enable data sharing and modernization of the electronic health record (EHR). PEO DHMS oversees the DoD Healthcare Management System Modernization (DHMSM®) program office, the Joint Operational Medicine Information Systems (JOMIS) program office and the Enterprise Intelligence and Data Solutions (EIDS) program office.

Together, these offices transform the delivery of health care for active duty military, veterans and their families by achieving nationwide interoperability and modernization of DoD's EHR, MHS GENESIS, as well as other capabilities. MHS GENESIS integrates inpatient and outpatient records, replacing select legacy DoD health care systems and connecting medical and dental information across the continuum of care.
