c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The Spacelabs Patient Monitoring System is a patient monitoring system used in hospital critical care, peri-operative, step-down units, and emergency care facilities to monitor patient physiological functions, including vital signs, electrocardiograms, pressure waveforms, oxygenation parameters, and alarms. Monitors provide real-time visual and numeric display at the bedside and alarms. Enterprise software components provide near-real-time display of trends for centralized review and analysis. Subsystems provide interfaces to other hospital information systems including 3rd party ECG management systems, Hospital Information Systems (ADT, laboratory, and electronic health records), enterprise notification systems (paging and messaging), 3rd party developed applications consuming Spacelabs-PMS data, and printers.

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

The PII collected will be used to match an individual with his/her medical diagnostic reports and to ensure accuracy when these reports are integrated in the medical records for that individual.

The PII collected will be used for mission-related purposes to support the delivery of health care services.
