c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

Special Needs Program Management Information System (SNPMIS) provides access to a comprehensive program of therapy, medical support, and social services for young TRICARE beneficiaries with special needs. SNPMIS is the Defense Health Agency (DHA) automated information system designed to ensure the Department of Defense (DoD) meets the unique information requirements associated with implementation of the Individuals with Disabilities Education Act (IDEA).

SNPMIS captures referral, evaluation, eligibility, and service plan data for children with special needs who are eligible for early intervention and special education services under IDEA. Management reports provide historical analysis to monitor ongoing improvements in quality of care initiatives. It also allows program managers to identify areas where additional services are needed. At the service level, activities of different programs can be compared to determine best practices that can be implemented throughout the Educational and Developmental Intervention Services (EDIS) clinics. SNPMIS is a workflow (subscribing system) hosted on the Healthcare Artifact and Imaging Management Solution (HAIMS) OpenText platform.

Categories of personally identifiable information (PII) and protected health information (PHI) collected by SNPMIS include personal descriptors, contact information, medical information, and educational program information. Records contained in the system may be retrieved by name or other unique identifier. SNPMIS is currently used in 43 EDIS clinics at Army, Navy, and Air Force installations worldwide.

Categories of individuals from whom SNPMIS collects PII and PHI include children of members of the Armed Forces and civilians (i.e., authorized DoD Beneficiaries) who are entitled to receive early intervention and special education services from the DoD under IDEA.

SNIPMIS is owned and managed by the Care and Benefits Integrated Systems Program Management Office (CBIS PMO)/Solution Delivery Division (SDD)/Program Executive Office (PEO) Medical Systems (J-6)/DHA.

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

SNPMIS collects PII for mission-related use. PII is collected by SNPMIS to monitor the developmental and educational services provided by EDIS clinics for quality assurance purposes and to ensure that DoD meets the unique information requirements associated with implementation of IDEA.

Information may also be collected via telephone interview. Parents often self-refer and the programs begin collecting some basic information at that point in the process.

SNPMIS itself does not require an OMB Control Number as it is not the initial point of information collection. However, information collected from other resources (i.e., interviews, other systems, forms) and stored in SNPMIS may be considered the initial point of collection and require further review. DHA IMCO will work with the DHA Paperwork Reduction Act (PRA) Liaison to review feeder systems and other collections to ensure full compliance with PRA requirements.
