2. OPEN SESSION

a. Administrative & Opening Remarks

Dr. Dickey opened the meeting and welcomed the attendees. Ms. Camille Gaviola, the Defense Health Board (DHB) Alternate Designated Federal Officer opened the meeting on behalf of CAPT Juliann Althoff, the DHB Designated Federal Officer; CAPT Althoff joined the group approximately 30 minutes into the meeting. Following a moment of silence to honor Service members, meeting attendees introduced themselves.

b. Decision Brief: Improving Defense Health Program Medical Research Processes

Dr. H. Clifford Lane, Chair of the Public Health Subcommittee, briefed the report to the Board for deliberation. This was the second time the report was presented; the first was at the February 9 DHB meeting, during which the Board invited members of the public to submit comments on the pre-decisional draft. These comments were considered as the Public Health Subcommittee completed their edits and revisions. At this briefing, the Board discussed the revised report at length, focusing primarily on the findings and recommendations. Board members and guests held a robust discussion on topics related to medical research in the Department of Defense (DoD), including:

- recruitment of civilian and active duty medical researchers;
- research funding restrictions; and
- challenges and opportunities related to human subjects research in DoD, including clinical investigations and Institutional Review Boards.

After deliberation, this report was approved as final by the Board with the addition of "on the genuine needs of the warfighter" after "the impact of the research" to Recommendation 2b.

c. Decision Brief: Deployment Health Centers, 2016-2017

Dr. George Anderson presented the report on behalf of the Subset Chair, Dr. Eve Higginbotham. The Board discussed the report at length, focusing in on the findings and recommendations. The group also discussed:

- the terminology used in the report related to the Deployment Health Clinical Center's (DHCC's) functions (e.g., using the term psychological health versus behavioral health);
- the lack of a standardized definition for psychological and behavioral health terminology within the Military Health System (MHS);
- the transition of clinical care services out of the DHCC in the 2012 timeframe;

- the pending name change of the DHCC under the DHA Operations Directorate (J-3); and
- the importance of multi-disciplinary assessments and registries for deployment-related medical illnesses.

The group also deliberated the recommendation that the DHB conduct future reviews every three years versus annually and agreed the three-year interval was adequate for now, as more frequent reviews could be requested as necessary. After deliberation, the report was approved as final; no changes were made to the findings or recommendations.

d. Tasking Update: Pediatric Health Care Services

Dr. Anderson, Health Care Delivery (HCD) Subcommittee Chair, and Dr. Jeremy Lazarus, Neurological/Behavioral Health (NBH) Subcommittee Chair, reviewed the subcommittees' efforts on the Pediatric Health Care Services tasking. Dr. Anderson and Dr. Lazarus reviewed areas of interest related to pediatric health care services, which may provide the foundation for future findings and recommendations, including:

- patient and family experience;
- data collection and reporting;
- standardization of care; and
- care coordination.

Board members and guests also discussed the challenges associated with nationwide shortages of certain pediatric specialists, services for medically complex pediatric patients, the Exceptional Family Member Program, TRICARE's Extended Care Health Option (ECHO), and the long waitlists for state Medicaid waiver programs, which varies state to state. This report is scheduled to be briefed out at the August 2017 meeting.

Prior to the meeting, the Board also received written statements from the public pertinent to this work, including:

- a white paper from Mr. Jeremy Hilton, which provided additional information and recommendations regarding the ECHO benefit as it relates to the DHB's tasking;
- a letter from Ms. Lisa Freeman on the long waitlists for state Medicaid waiver programs;
- a letter from Dr. Lori Hensic of The American Military Family Partner Association on the top three health care needs of lesbian, gay, bisexual, and transgender military families; and
- comments from Ms. Kara Tollett Oakley, Chair of TRICARE for Kids Coalition, regarding challenges related to policy and practice with regard to access, coverage, and accountability for pediatric health care services.

These written statements were also provided to the HCD and NBH subcommittees for their consideration in this tasking.

The next DHB meeting is scheduled for August 10, 2017 in Falls Church, Virginia.
