MEDICAL DEPARTMENT PERSONNEL SHALL ASSIST THEIR COMMANDERS IN COMPLYING WITH THIS RESPONSIBILITY BY ENSURING THEY PROPERLY IDENTIFY, SCREEN, AND EDUCATE SERVICE MEMBERS, DOD CIVILIANS, AND DOD CONTRACTORS TO BE VACCINATED PRIOR TO ADMINISTERING THE SMALLPOX VACCINE AND ENSURING APPROPRIATE MEDICAL EVALUATIONS FOR ANY VACCINE-RELATED ADVERSE EVENT.
