- Beneficiary Eligibility Diagnosis requirements; ECHO extension, Non-clinical support
- <u>ASN</u> Specialized care managers/coordinators that are assigned to each new family entering the ACD

■ Parent/Family Support – New Contractor responsibilities to support parents/families


### Areas of Change: Contractor Requirements

- <u>Outcome Measures Oversight</u> Contractor requirements for collection of valid measures
- Provider Networks Access to care
