JMOC is a five-day course provides training in joint and combined operational and medical planning that will span the operational environment from point of injury/illness to the appropriate capability of care across the full spectrum of military operations. JMOC familiarizes students to the Joint Operational Planning and medical planning process; policy guidance and information relevant to planning, and Joint Staff publication to include Joint Publication 4-02, *Health Services Support*, and CJCSM 3122.03C, *Joint Operations Planning and Execution (JOPES)*, *Vol II.*

HOW WOULD I BENEFIT FROM THIS COURSE?

Acquire the tools to effectively provide doctrinally sound, operationally integrated leadership in Joint Health Service Support (HSS) operations while meeting current mission requirements. With the Joint Operational and Medical Planning Processes as the focus, student will be able to:

- Examine the planning factors and elements related to joint, coalition, and USG interagency medical planning.
- Support the joint medical planning community in the development of the systems analysis, operational risk assessment, and field medical services planning.
- Discuss HSS operations in the Joint Operations Area.
- Categorize DoD and USG interagency deployable Health Service Support (HSS) capabilities.
- Summarize the military medical continuum of care to include the patient movement system.
- ❖ Identify resources and processes that are available to Medical Planners and Action Officers.
- Demonstrate Joint Operational and Health Service Support Planning.

WHO QUALIFIES TO ATTEND IMOC?

- Open to Department of Defense (DoD) medical department personnel assigned to Combatant Commanders, Service Headquarters, Joint Task Forces, and joint organizations.
- ❖ If space available, other DoD medical department personnel, United States Government (USG) Interagency and Allied personnel may attend.
