Dear Mr. Chairman:

I am pleased to forward the report prescribed in Section 751 of the National Defense Authorization Act for Fiscal Year 2001 Section 751 requires the Secretary of Defense to submit to Congress an annual written report on the number of members of the Armed Forces who have been separated as a result of refusing to participate in the Anthrax Vaccine Immunization Program (AVIP).

During the January 1 through December 31, 2003 reporting period, 18 service members were separated as a result of refusing to participate in AVIP out of a total of 436.513 Service members vaccinated

As noted in the attached table, the separations rate for Calendar Year (CY) 2003 is comparable to what was observed in CY 2002 and 2001 and lower than it was in CY 2000

As of December 31, 2003, over 1.034,640 Service members have received over 3.736.170 doses of vaccine in the AVIP
