Dear Mr. Chairman:

I am pleased to forward the report prescribed in Section 751 of the National Defense Authorization Act for Fiscal Year 2001. Section 751 requires the Department of Defense to submit to Congress an annual written report on the number of service members who have been separated as a result of refusing to participate in the Anthrax Vaccine Immunization Program (AVIP).

From January 1 through December 31, 2006, no service members were separated as a result of refusing to participate in AVIP. During this time period, service members were afforded the vaccine on a voluntary basis.

For your information, attached is a table identifying the service, service component, and rank of the service members separated from CY 2001 to CY 2006.
