### **EXECUTIVE SUMMARY**

This report is in response to House Report 116–84, page 313, accompanying H.R. 2968, the Department of Defense (DoD) Appropriations Act for Fiscal Year (FY) 2020. The House Appropriations Committee encourages the Assistant Secretary of Defense for Health Affairs (ASD(HA)) to continue Creative Arts Therapies programs at the National Intrepid Centers, and to continue collaborations with the Creative Forces initiative of the National Endowment for the Arts (Creative Forces NEA). This report summarizes the Department's funding in support of available options for Creative Arts Therapies at the National Intrepid Center of Excellence (NICoE) and Intrepid Spirit Centers (ISCs).

#### **BACKGROUND AND PURPOSE**

House Report 116–84 supports the Department's efforts to include Creative Arts Therapies as part of an interdisciplinary treatment model. The Committee recognizes that Creative Arts Therapies show potential in treating Service members with traumatic brain injury (TBI) and psychological health conditions, and encourages the ASD(HA) to continue Creative Arts Therapy programs at the National Intrepid Centers and collaborations with the Creative Forces NEA.

The Defense and Veterans Brain Injury Center reported 413,858 TBI cases in the military since 2000, of which the majority were classified as mild (82.8 percent). According to an analysis of 2017 DoD data using the average monthly population of Active Duty Service members, National Guard, and Reservists enrolled in TRICARE (1,471,915), the estimated prevalence rate of posttraumatic stress disorder (PTSD) diagnosis was 1.9 percent (28,288), while the incidence rate was 1.0 percent (16,189). Active Duty Service members are at increased risk of physical and psychological trauma that may result in TBI, PTSD, or both conditions. TBI involves an altered level of consciousness or disruption in cognitive functioning, memory loss, or neurological deficits. PTSD symptoms often overlap with TBI, causing anxiety, depression, cognitive deficits, irritability, and sleep disruptions. Among Veterans with positive TBI screens, 80 percent show comorbid psychiatric conditions. Up to half of Service members with combatrelated TBIs meet the criteria for PTSD.

Creative Art Therapies are increasingly accepted forms of complementary and integrative care for Service members diagnosed with TBI and PTSD. The Creative Forces NEA Military Healing Arts Network is an initiative of the NEA in partnership with the DoD, Department of Veterans Affairs, and state and local arts agencies, which aims to improve the health, wellness, and quality of life for military and Veteran populations exposed to trauma through Creative Arts Therapies. The Creative Forces program has three components: clinical, community, and capacity. In the clinical setting, Creative Arts Therapists provide care through music, dance/movement, art, and creative writing to enable use of self-expression in treatments. In community-based settings, Creative Forces provides Creative Arts opportunities for Service members and Veterans. Creative Forces also invests in capacity-building efforts, including the development of toolkits, training materials, and other resources to support best practices in serving Service members and Veterans with TBI and PTSD. The purpose of this report is to provide information regarding the Department's funding resources for Creative Arts Therapies in

the treatment of TBI and PTSD. The information below reflects input compiled from the Defense Health Agency (DHA), NICoE and 10 ISCs on key funding requirements for expansion of Creative Arts Therapies at individual sites. This funding information intends to inform enhancement and expansion of Creative Arts Therapies services across the Military Health System (MHS).

#### RESULTS

# National Intrepid Center of Excellence and Intrepid Spirit Centers

The Department provided \$1,420,958 in funding for Creative Arts Therapy Programs in FY 2018 and \$1,525,104 in FY 2019, totaling \$2,946,062 in funding for art, music, dance, and creative writing therapies. This funding was for current levels of effort, positions, travel, budget, supplies, and equipment. Table 1 summarizes total funding in support of Creative Arts Therapies by site, while the Appendix provides detailed information for FY 2018 and FY 2019.

As part of an ongoing assessment, the DHA continues to incorporate data-driven decisions to integrate emerging and new therapies for the optimal treatment of TBI and PTSD.
